

**INDIAN RIDGE WATER CONSERVANCY DISTRICT
RESOLUTION # 1 – 22 - 2020
A RESOLUTION SETTING NEW
CULINARY WATER RATES**

WHEREAS: Indian Ridge Water Conservancy District owns and operates a Culinary Water System, and

WHEREAS: Costs associated with operating the Culinary Water System continue to increase, and

WHEREAS: The Indian Ridge Water Conservancy District Board of Directors and personnel have studied the District's budget and found that for at least the past three (3) years the District has been operating in arrears, and

WHEREAS: The Indian Ridge Water Conservancy District Board sees the need to make increases to the Culinary Water Rates, and

WHEREAS: The Indian Ridge Water Conservancy District Board wants to make sure the proper rates are charged in order to be totally fair and equitable to both the citizens and the District, and

WHEREAS: The Indian Ridge Water Conservancy District advertised a Public Hearing to be held on June 25, 2019 at the Fairview City Fire Station, 165 N. Main, Fairview, Utah, and

WHEREAS: The notice of advertisement was published in the Sanpete Messenger on May 30, 2019, June 6, 2019, and June 13, 2019, and it was also posted on the Utah Public Notice Website on May 23, 2019, and individual letters were sent to all District water users on May 25, 2019, and also on May 25, 2019, a notice of the Public Hearing was posted on the Bulletin Board at the gate entrance of the Subdivision, and

WHEREAS: On June 25, 2019, The Indian Ridge Water Conservancy District did in fact convene and hold the Public Hearing and Budget Meeting, as it had been advertised, at which time the Board of Directors passed and adopted new Culinary Water Rates, by unanimous vote, and

WHEREAS: The Indian Ridge Water Conservancy District has adopted Policies governing its operation which provides, among other things, the right to change or fix Culinary Water Rates by Resolution,

NOW THEREFORE IT IS HEREBY RESOLVED BY THE CHAIRMAN AND BOARD OF THE INDIAN RIDGE WATER CONSERVANCY DISTRICT, SANPETE COUNTY, UTAH, AS FOLLOWS:

SECTION 1: CULINARY WATER RATES. All Culinary Water Rates historically charged, for water services, are hereby ratified and confirmed.

As of July 1, 2019, all culinary water user rates shall be as follows:

1. Annual Rate: \$320.00 for up to 1,000 gallons annually, to be paid at a rate of \$80.00 per quarter according to the District billing schedule.
2. \$15.00 per 1,000 gallons for all usage over 1,000 gallons annually starting from the October 2019 meter reading.


SECTION 2: EFFECTIVE DATE AND POSTING OF RESOLUTION. This Resolution shall take effect on January 22, 2020 and following the posting thereof in the following three (3) public and conspicuous places:

- 3- Sanpete County Court House, North Lobby Bulletin Board
